Information on the processing of personal data (pursuant to Article 13 of EU Regulation 2016/679)

Pursuant to art. 13 of European Regulation 2016/679 (hereinafter GDPR), this information notice on the protection of individuals regarding the processing of personal data is drawn up. We therefore invite the contractor of the service to carefully read the following information, which contains some useful indication regarding the processing of personal data related to the provision of services provided by Costa Rossa società semplice agricola.

Subject of data processing

The data processed are: personal data; contact information such as phone number, email address, references and specific requests. The personal data entered will be processed exclusively for the provision of information as requested by the customer and for all activities instrumental thereto, including the purposes of establishing and managing contractual relationships of any kind, as defined by sector regulation. The provision of the requested data is essential to carry out the service and any refusal to provide such data will result in failure to satisfy the request; the treatment will be carried out both manually and through the use of IT procedures; the data will not be disseminated.

The personal data processed are the following:

- · personal identification data (personal data, email addresses, etc.)
- · genetic data (data revealing racial origin, ethnicity, etc.)
- · biometric data (these are the data relating to the physical, physiological and / or behavioral characteristics that can be deduced from the documentation kept)
- · political opinions (where declaratory statements are made),
- · religious or philosophical beliefs (where declarations are made)
- · trade union membership (where declarations are made)

Any other particular data acquired in fulfillment of the mandate conferred.

Purpose of data processing

The data will be processed to allow the performance of the service provided by Costa Rossa società semplice agricola to the Customer as indicated in the contract.

The same data will be processed lawfully, fairly and with the utmost confidentiality, mainly with electronic and IT tools and stored both on computer media and on paper and on any other type of suitable support, in compliance with the minimum security measures as provided for by the Code and the Regulation.

The data will be used for sending commercial information, newsletters, invitations, etc... only if expressly authorized by flagging the relevant checkbox.

Legal basis of the processing

The execution of a contract or the execution of pre-contractual measures requested by the customer is the legal basis legitimizing the processing of Personal Data provided voluntarily or collected automatically by sending e-mails or communications.

Processing and storage methods

The treatment will be carried out in an automated and / or manual form, in compliance with the provisions of art. 32 of the GDPR 2016/679 on security measures, by persons specifically appointed and in compliance with the provisions of art. 29 GDPR 2016/679.

We would like to inform you that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 GDPR 2016/679, subject to your free and explicit consent expressed at the foot of this statement, your personal data will be kept for the period of time necessary to achieve the purposes for which they are collected and processed.

Consequences of failure to provide personal data

With regard to personal data relating to the execution of the contract of which you are a party or relating to the fulfillment of a regulatory obligation, failure to communicate personal data prevents the completion of the contractual relationship itself.

Communication of data

The Data Controller may communicate the data for the purposes set out in art. 2 to Supervisory Bodies, Judicial Authorities and to all other subjects to whom communication is mandatory by law for the accomplishment of the purposes provided for by law.

Some processing operations may also be carried out by other third parties to whom Costa Rossa società semplice agricola entrusts certain activities, or part of them, functional to the provision of services. On these additional parties, designated as Data Processors, appropriate obligations are imposed by contract or other legal act under EU or Member State law regarding the protection of personal data through operational instructions, with particular reference to the adoption of appropriate technical and organizational measures, in order to guarantee the confidentiality and security of data pursuant to art. 32 of the Regulation.

Profiling and Dissemination of data

Your personal data are not subject to dissemination or to any fully automated decision-making process, including profiling.

Rights of the interested party

The rights granted to you by the GDPR include those of:

- · request access to your personal data and information relating to them; the correction of inaccurate data or the integration of incomplete data; the cancellation of personal data concerning you (upon the occurrence of one of the conditions indicated in Article 17, paragraph 1 of the GDPR and in compliance with the exceptions provided for in paragraph 3 of the same article); the limitation of the processing of your personal data (in the event of one of the hypotheses indicated in Article 18, paragraph 1 of the GDPR);
- · request and obtain in cases where the legal basis of the processing is the contract or consent, and the same is carried out by automated means your personal data in a structured and machine-readable format, also in order to communicate such data to another data controller (so-called right to the portability of personal data);

- · oppose at any time to the processing of your personal data in the event of particular situations that concern you;
- · withdraw your consent at any time, limited to cases where the processing is based on your consent for one or more specific purposes and concerns common personal data (for example date and place of birth or place of residence), or particular categories of data (for example data revealing your racial origin, your political opinions, your religious beliefs, health or sex life). Treatment based on consent and carried out prior to the revocation of the same shall, however, remain lawful;
- · file a complaint with a supervisory authority (Authority for the protection of personal data www.garanteprivacy.it).
